The Standalone Edition can be used without any extra prerequisites and is running as a standalone app covering all aspects of agile project management such as Scrum or KANBAN.

The Focused Build Edition is based on the Focused Build Add On as part of SAP Solution Manager 7.2. This Edition covers only Scrum as methodology and is highly integrated into the SAP Focused Build methodology to manage work packages, work items and tasks.

On the other hand, the Solution Manager Edition is based on the SAP Solution Manager ChaRM process. With this you can manage all process types in an agile way. Link the release cycle as Sprints work on your change documents in an agile mode. This Edition also covers only Scrum as methodology and is highly integrated into the SAP Solution Manager process.

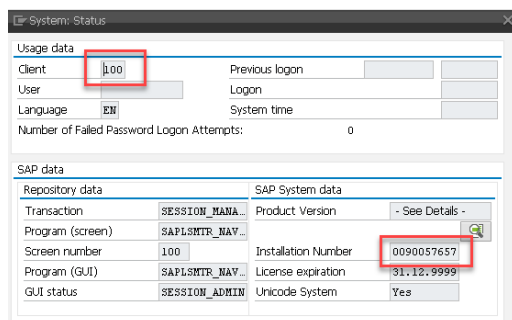
